DURING THE YEAR ENDED JUNE 30, 2022, THE ORGANIZATION HOUSED 292 PEOPLE, PROVIDED 26,833 NIGHTS OF SAFE SHELTER, AND SERVED 28,856 MEALS WITH THE HELP OF 380 VOLUNTEERS PROVIDING 6,678 HOURS OF SERVICE. THE CORONAVIRUS (COVID-19) PANDEMIC THAT HIT THE UNITED STATES IN MARCH 2020 SIGNIFICANTLY DECREASED EACH OF THESE FIGURES.

THE SHELTER SERVICES PROGRAM PROVIDES 60 BEDS, CASE MANAGEMENT, MEALS, AND SHOWERS 365 NIGHTS A YEAR TO MEN WHO ARE HOMELESS IN THE ST. LOUIS AREA. 90% OF SHELTER RESIDENTS CREATE A HOUSING GOAL PLAN AND MEET WITH A CASE MANAGER TO WORK TOWARDS LOCATING STABLE HOUSING IN THE COMMUNITY.

NURSING, LIFE SKILLS DEVELOPMENT, CASE MANAGEMENT, SOCIAL OUTINGS, MEALS, LAUNDRY, AND INDIVIDUAL AND GROUP THERAPY ARE PROVIDED IN A SAFE, SUPPORTIVE ENVIRONMENT TO HELP RESIDENTS ATTAIN STABLE HOUSING IN THE COMMUNITY.
